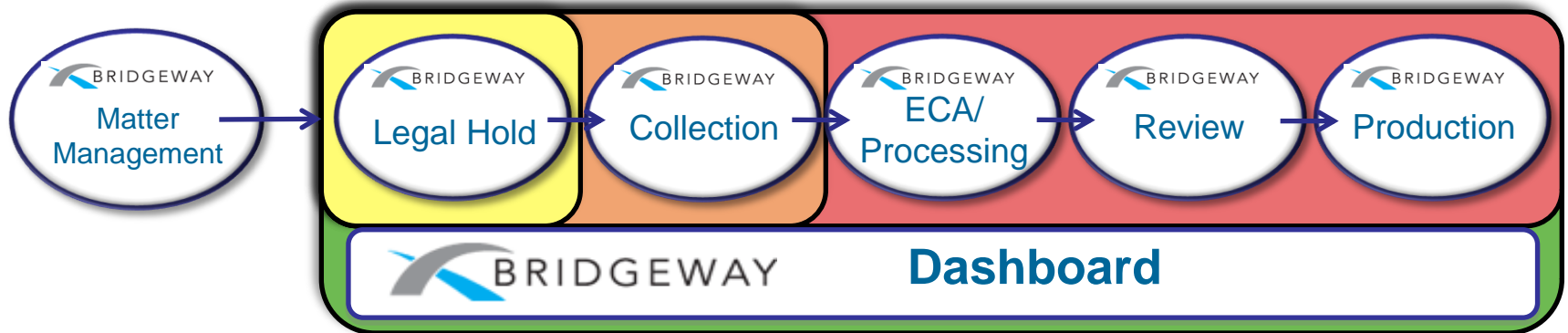

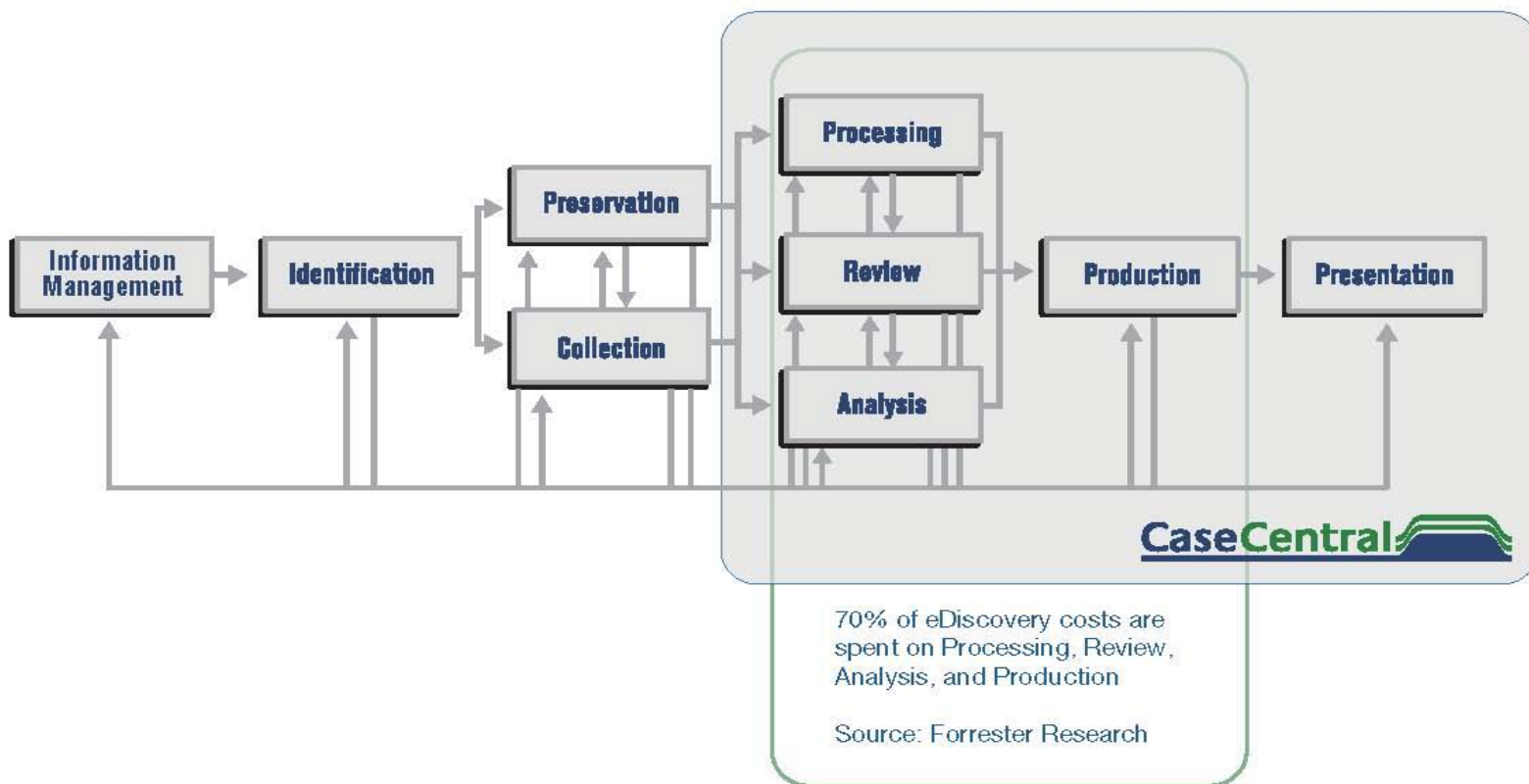

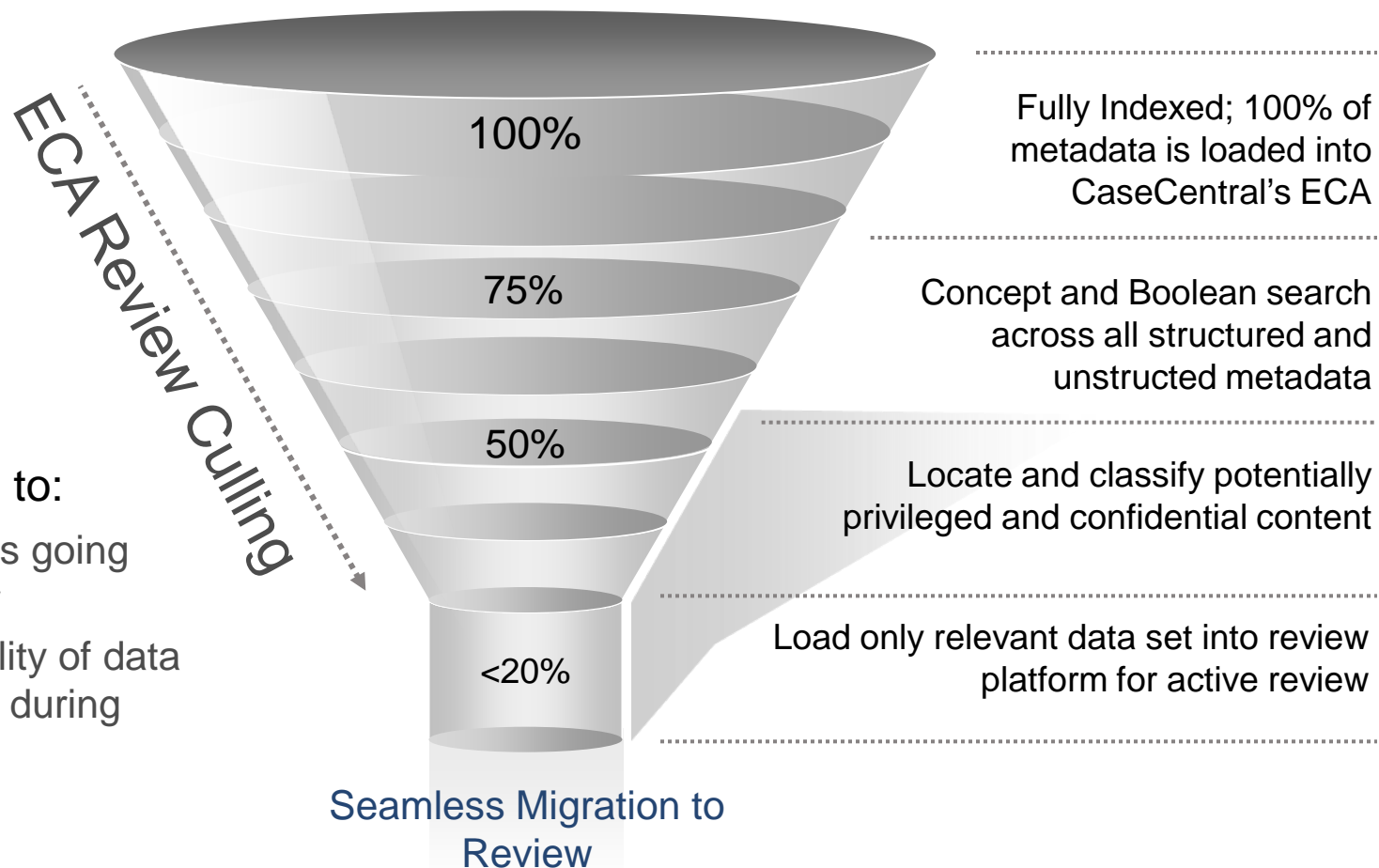

Electronic Discovery Reference Model www.edrm.net



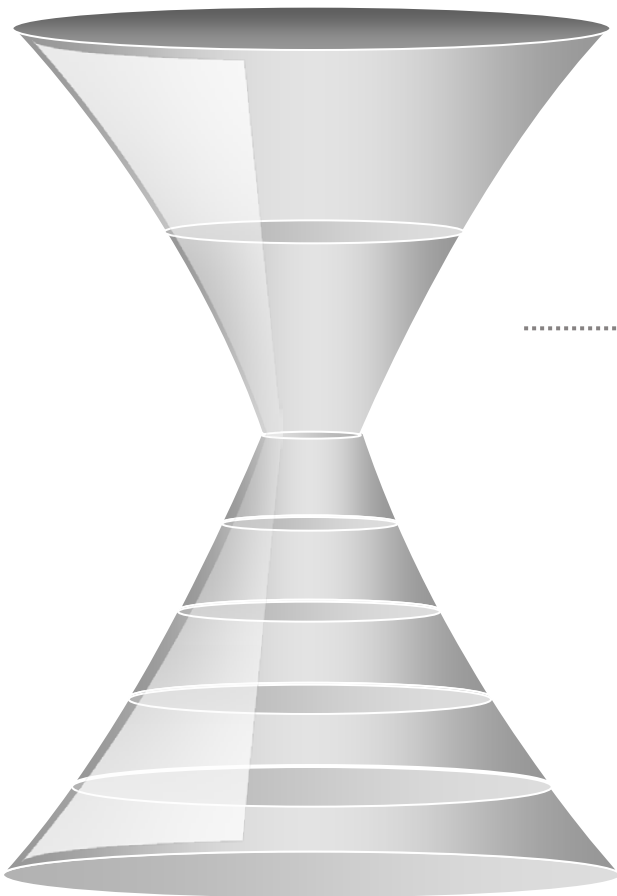

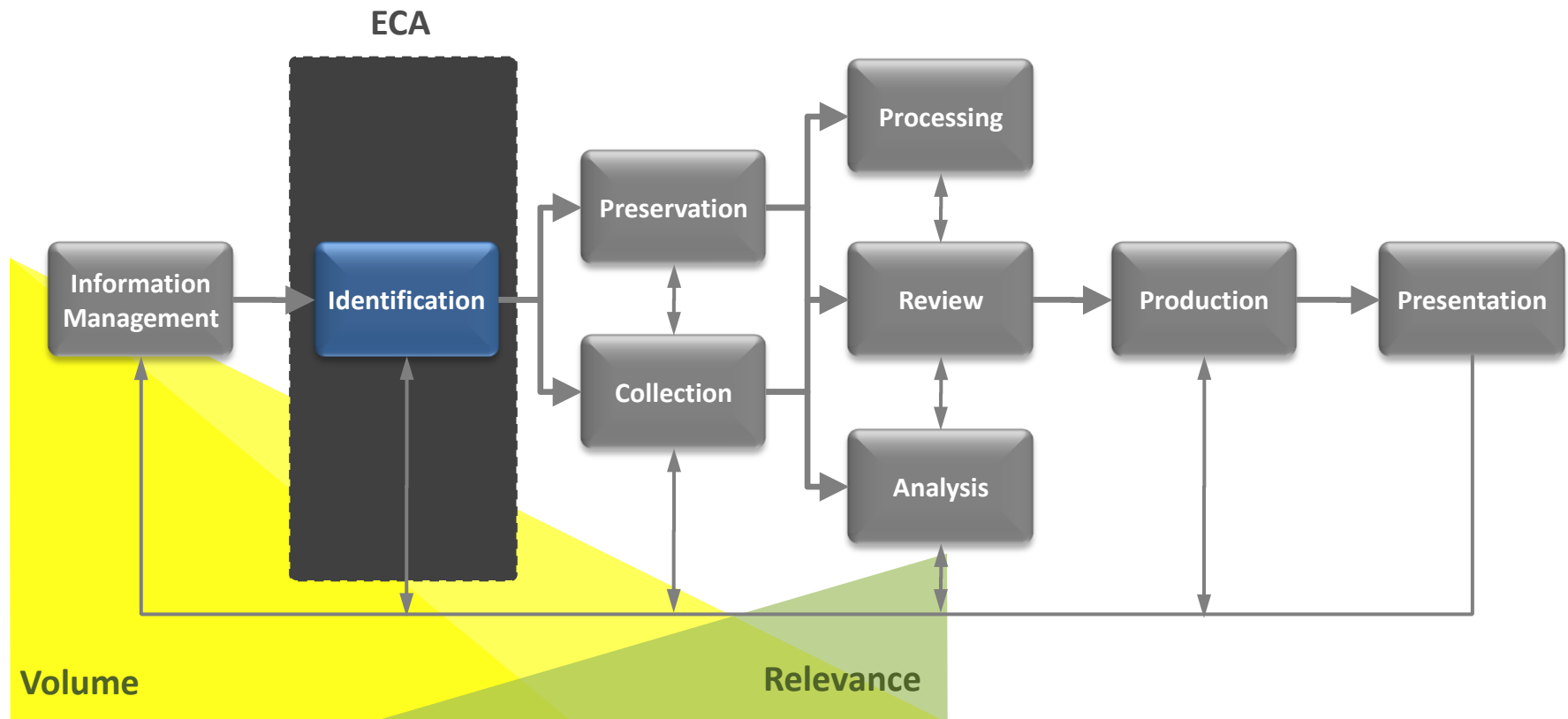
