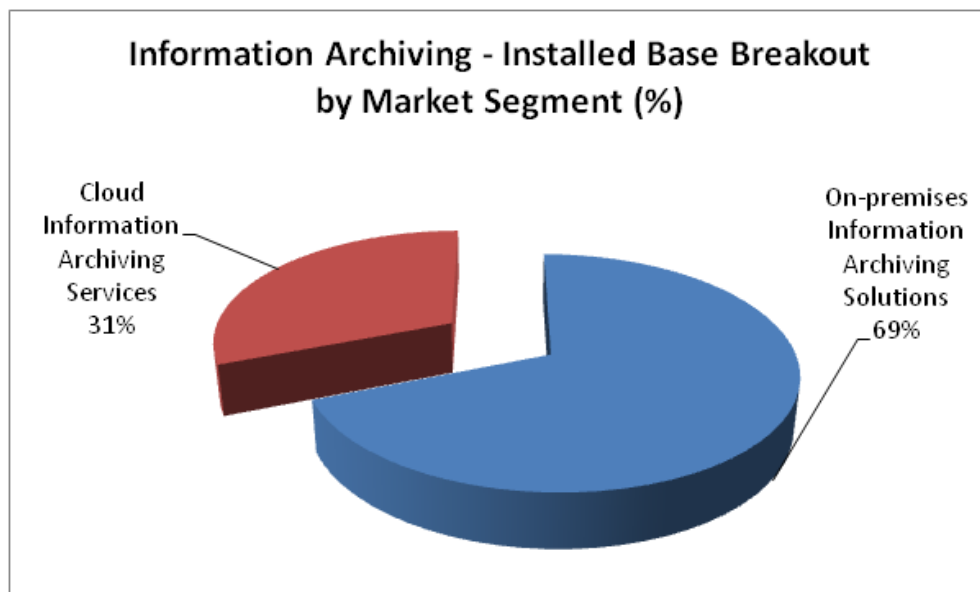


Figure 1: Information Archiving Market – Breakout by Market Segment, 2012
