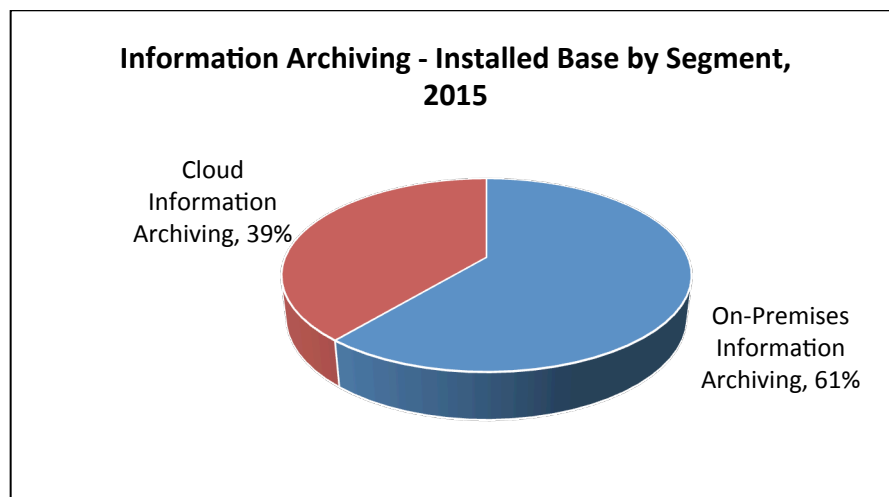


Figure 2: Information Archiving Market – Breakout by Segment, 2015
